Payment transactions are securely done via PayPal with all credit and debit cards.

We ship as soon as possible. We usually ship within two working days after receiving the order, granted we received payment. Orders are packed and shipped Worldwide from Barcelona. Delivery time can vary depending on the country. Orders are shipped via Correios Express, taking two days to arrive in Spain and 2-3 weeks in the rest of the World. A signature will be required for the reception of the package.
